# **FRIESIAN HORSE ASSOCIATION OF NORTH AMERICA**

## **MEMBERSHIP CATEGORIES**

### **ASSOCIATE MEMBER**

Any person who is a citizen or resident of the United States or Canada and does not own an FPS registered Friesian horse can become an Associate Member. An Associate Member in good standing will receive the general communications of the Association and may attend Association General Membership meetings but cannot vote in Association proceedings and is not eligible for election to the Board of Directors.

### **INDIVIDUAL MEMBER**

Any owner of at least one FPS-registered Friesian horse and who is a citizen or resident of the United States or Canada can become an Individual Member. An Individual Member will receive the general communications of the Association, may attend Association meetings, is entitled to one vote in Association proceedings and, if at least eighteen years old, is eligible for election to the Board of Directors.

### **FAMILY OR BUSINESS MEMBER**

Two or more members of a family, which is defined as husband and/or wife and children under the age of eighteen years, who are citizens or residents of the United States or Canada, or a partnership or corporation registered in the United States or Canada can become a Family or Business Member provided at least one FPS-registered Friesian horse is owned within or by the group. A Family or Business Member in good standing will receive the general communications of the Association, may attend Association meetings, is entitled to one vote in Association proceedings and one member of the group who is at least eighteen years old is eligible for election to the Board of Directors.
